Ill Health	All	Variable	<ul style="list-style-type: none"> ➤ Managers/Coaches to be aware of any health problems players or volunteers may have. ➤ Advise players/Volunteers to carry any medication they may need. ➤ Parents to stay at training and matches for players who are too young to administer their own medicine. ➤ Anyone with contagious illness should stay away from activities. 	<ul style="list-style-type: none"> ➤ Managers/Coaches ➤ Managers/Coaches

Worsening of an injury	All	Variable	<ul style="list-style-type: none"> ➤ A minimum of one qualified first aider must be available to the team during training/playing to prevent the condition worsening and if possible to sustain life. ➤ First aid training to be refreshed every 3 years. ➤ Manager/Coach should ensure a working mobile phone is available at every training session or they know where the nearest public telephone is located. ➤ First aid box to be carried to all games/training & checked at intervals and stocks replenished as required. ➤ Studs to be checked for safety. ➤ Players should seek medical advice after suspected head injury & resume play only under Doctors' guidance. ➤ Ensure that vehicles are parked so that ambulance access is readily available to home pitches/training facilities. 	<ul style="list-style-type: none"> ➤ Manager ➤ Manager/Training Officer ➤ Manager/Coach ➤ Referee ➤ Managers/Coaches in consultation with parents/player. ➤ Managers/Coaches

See individual plans. ➤ Manager/Coach to acquaint themselves with, and follow, the published fire instructions at any indoor venue. ➤ Appropriate venues with fire assessments & fire fighting equipment in place to be used. ➤ No smoking policy within the club. 	<ul style="list-style-type: none"> ➤ Health & Safety /Officer ➤ All to adhere to plans. ➤ Manager/Coach
Manual Handling	All	Low	<ul style="list-style-type: none"> ➤ Manual Handling Poster to be displayed in storeroom & all advised to read. ➤ Goals & other heavy or awkwardly shaped items to be carried by two or more persons. ➤ Players should not be picked up & carried by club personnel unless they are in immediate danger. ➤ Café items such as boxes/oven etc should be carried by 2 or more people. 	<ul style="list-style-type: none"> ➤ Health & Safety Officer ➤ Manager/Coach/Helper ➤ All ➤ All Volunteers

Using / handling substances that may be hazardous to health	All	Low	<ul style="list-style-type: none"> ➤ Use personal protective clothing appropriate to the substance ie disposable gloves for food handling/ washing up. ➤ Wear disposable gloves for the provision of first aid to avoid bodily fluids. ➤ Avoid first aid sprays. ➤ Gloves & disposal equipment supplied for removal of animal excrement from pitches. 	<ul style="list-style-type: none"> ➤ All volunteers ➤ Managers/Coaches
Violence / Threats / Abuse	All	Low	<ul style="list-style-type: none"> ➤ All families/players should receive a copy of the club code of conduct. ➤ Club Committee to treat seriously any allegations of improper conduct. 	<ul style="list-style-type: none"> ➤ Manager/Coach ➤ Committee

Scalding	Purple Café Helpers/ Public	Low	<ul style="list-style-type: none"> ➤ No under 16's in the kitchen during café hours. ➤ Tea urn to be positioned so that it pours over the kitchen sink where it should be emptied & cooled before moving. ➤ Notice in kitchen. ➤ Milk for drinks to be positioned on table close to hatch. 	<ul style="list-style-type: none"> ➤ Café Managers & Helpers.
Food Poisoning	All	Low	<ul style="list-style-type: none"> ➤ Foods should be kept refrigerated before use. ➤ Cooked foods should be kept hot & not cooled & reheated. ➤ Foods purchased should be within sell-by dates. ➤ Frozen meats should be used within 3 months of freezing. ➤ Frozen foods should be thoroughly defrosted in a fridge before use. ➤ Foods should be kept covered when not being prepared to prevent insect/foreign body contamination. 	<ul style="list-style-type: none"> ➤ Café Managers & Volunteers
Allegations of Child Abuse	Volunteers	Low	<ul style="list-style-type: none"> ➤ Volunteers to avoid being alone with a child ➤ Follow Club Guidelines & Policies ➤ Ensure same sex as children chaperone is present for training & matches whenever possible 	<ul style="list-style-type: none"> ➤ All Club Volunteers ➤ Managers/Coaches
Burns sustained during cooking.	All	Low	<ul style="list-style-type: none"> ➤ Use appropriate personal protective clothing eg oven gloves and aprons. ➤ Remove oven & urn from kitchen ONLY when cool. ➤ Ensure safe practices in kitchen are maintained i.e. slippery floors prevented etc. 	<ul style="list-style-type: none"> ➤ All Volunteers

Missing Child	Players	Low	<ul style="list-style-type: none"> ➤ To ensure that all children are collected by a parent/guardian. 	<ul style="list-style-type: none"> ➤ Managers/Coaches/Parent
